A. CALL TO ORDER

D. CONSENT AGENDA

1. Approval of April 21, 2016 Meeting Minutes

Ms. Earle moved to approve the April 21, 2016 CAC meeting minutes. Mr. Bacon seconded the motion and it was passed unanimously.

2. Consideration of Membership Certifications for the Okaloosa County and Walton County Transportation Disadvantaged Coordinating Boards.
This item was not reviewed by the committee.

E. ACTION ITEMS:

1. Resolution O-W 16-11: Adopting the Okaloosa-Walton Transportation Planning Organization Fiscal Year (FY) 2017-FY 2021 Transportation Improvement Program (TIP) and Authorizing the

WFRPC Staff to Administratively Amend the FY 2017- FY2021 TIP to Include Projects in the Florida Department of Transportation's (FDOT's) Variance Report. Mr. Kramer, WFRPC staff, presented a brief overview of this item to the committee. Mr. Bacon stated that an appendix or acronyms list would be very helpful. There were no other questions or comments from the committee.

Mr. Readdy moved to recommend the TPO authorize the TPO chairman sign Resolution O-W 16-11 authorizing the WFRPC staff to administratively amend the FY 2017-FY 2021 TIP to include the projects in the FDOT's variance report. Mr. Cox seconded the motion and it was passed unanimously.

2. Resolution O-W 16-12: Amending the fiscal Year (FY) 2016-FY 2020 Transportation Improvement Program (Tip) For Project Number 4394521, Addition of Design Funds for Walton County Advanced Transportation Innovation Program. Mr. Kramer, WFRPC Staff, presented this item to the committee. There was general discussion, but no questions from the committee.

Mr. Bacon moved to recommend the TPO authorize the TPO chairman to sign Resolution O-W 16-12 amending the FY 2016-FY 2020 Transportation Improvement Program for project number 4394521. Mr. Cox seconded the motion and it was passed unanimously.

3. Resolution O-W 16-13: Adopting the 2040 Okaloosa-Walton Transportation Planning Organization (TPO) Long Range Transportation Plan (LRTP) Financial Resources Technical Report. Mr. Page, Atkins staff, presented this item to the committee with a PowerPoint presentation. Mr. Edwards asked if this was for the whole state or just Walton county. Mr. Page stated that this was just a plan and that there is no money for the project yet. There was general discussion, but no further questions or comments from the committee.

Mr. Readdy moved to recommend the TPO authorize the TPO chairman to sign Resolution O-W 16-13 adopting the 2040 Okaloosa-Walton Long Range Transportation Plan Financial Resources Technical Report. Mr. Covey seconded the motion and it was passed unanimously.

4. Resolution O-W 16-15: Adopting the Transportation Alternatives Program (TAP) Ranked Projects. Ms. Cook, WFRPC staff, presented this item to the committee with a PowerPoint presentation. Mr. Midgette asked if Walton County submitted any applications this year. Ms. Cook responded that they did not. There was general discussion on the point ranking criteria. The committee had no further questions or comments.

Mr. Readdy moved to recommend the TPO authorize the TPO chairman to sign Resolution 16-15 adopting the Transportation Alternatives Program ranked projects. Ms. Earle seconded the motion and it was passed unanimously.

5. Resolution O-W 16-16: Adopting the Congestion Management Process Plan (CMPP) Minor Update. Ms. Cook, WFRPC staff, presented this item to the committee. There were no questions or comments from the committee.

Ms. Earle moved to recommend the TPO authorize the TPO chairman to sign Resolution 16-16 adopting the Congestion Management Process Plan Minor Update. Mr. Cox seconded the motion and it was passed unanimously.

7. Consideration of a Citizens' Advisory Committee (CAC) Application from Mr. Jim Wood. Mr. Youpatoff, WFRPC staff, presented this item to the committee. There were no questions or comments from the committee.

Mr. Readdy moved to approve the consideration of a Citizens' Advisory Committee application from Mr. Jim Wood. Ms. Coleman seconded the motion and it was passed unanimously.

8. Election of Chairs and Vice Chairs for Fiscal Year (FY) 2017 (July 1, 2016 through June 30, 2017). The election committee met prior to this meeting. It was recommended that Chairman Steven Czonstka remain Chairman and that Ms. Yvonne Earle be the Vice Chairperson. There were no questions or comments.

Mr. Covey moved to recommend the TPO authorize the TPO chairman to elect Steven Czonstka and Yvonne Earle as CAC Chair and Vice Chair. Mr. Readdy seconded the motion and it was passed unanimously.

9. Resolution O-W 16-22: Adopting the revised Fiscal Year (FY) 2017- FY 2018 Okaloosa-Walton Transportation Planning Organization Unified Planning Work Program. Ms. Washnock, WFRPC Transportation Planning Manager, presented this item to the committee. There were no questions or comments from the committee.

Mr. Bacon moved to recommend the TPO authorize the TPO chairman to sign Resolution 16-22 adopting the revised Okaloosa-Walton TPO Unified Planning Work Program. Ms. Coleman seconded the motion and it was passed unanimously.

F. FDOT UPDATE

Mr. Youpatoff, WFRPC staff, stated that Mr. Bryant Paulk, Florida Department of Transportation staff, was supposed to present this item to the committee, but was unable to attend this meeting.

2. Review of the Draft Okaloosa-Walton Transportation Planning Organization 2040 Long range Transportation Plan Needs Plan. Mr. Page, Atkins staff, presented this item to the committee with a PowerPoint presentation. He did a brief overview of all committed projects. Mr. Edwards stated he is concerned that this will not solve the traffic issues. There was general discussion, but no further questions or comments from the committee.
